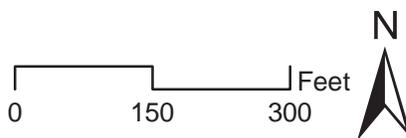

# Project Location Map


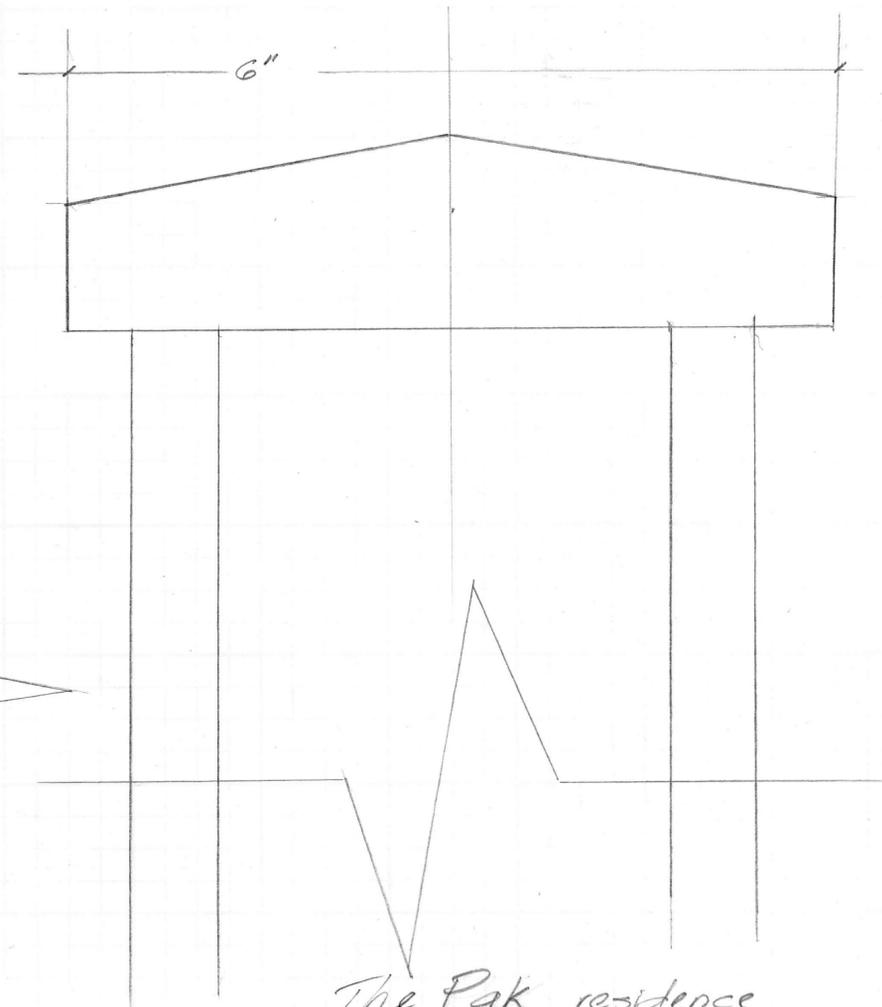
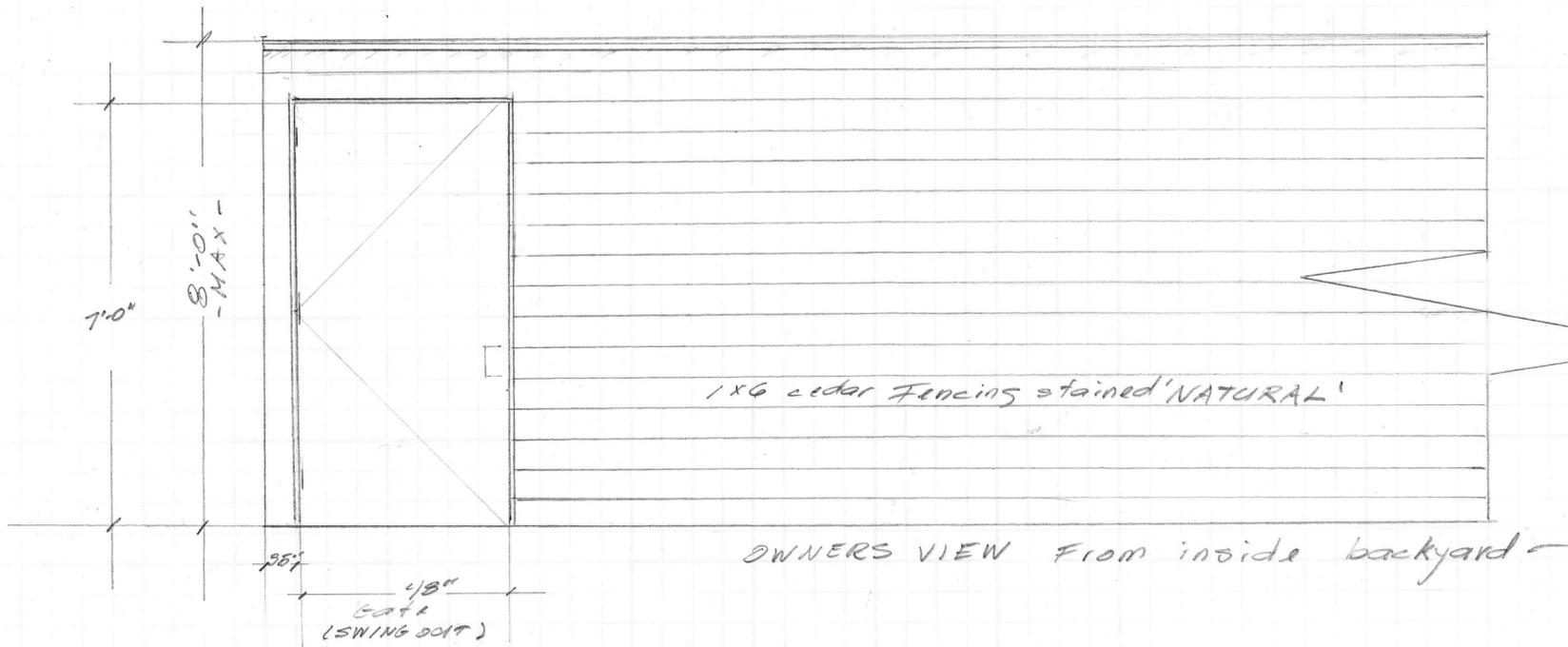
