NOTICE OF PUBLIC HEARING

Notice is hereby given that the Planning Commission of the City of Campbell has set the time of 7:30 p.m., or shortly thereafter, on Tuesday, **July 9, 2019**, in the City Hall Council Chambers, 70 North First Street, Campbell, California, for a Public Hearing to consider the application of Greg Vasquez, on behalf of the Campbell United Church of Christ, for a Sign Permit (PLN2019-83) to replace a 36 square-foot monument sign with a 40 square-foot manual readerboard sign on property located at **400 W. Campbell Avenue**. Staff is recommending that this item be deemed Categorical Exempt under CEQA.

Interested persons may appear and be heard at this hearing. Please be advised that if you challenge the nature of the above project in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this Notice, or in written correspondence delivered to the City of Campbell Planning Commission at, or prior to, the Public Hearing. Plans and architectural drawings may be viewed at the Planning Division office during normal business hours (8:00 a.m. – 5:00 p.m.) and on the City's 'Public Notices' web page (<http://www.cityofcampbell.com/501/Public-Notices>) under 'Planning Commission'.

Decisions of the Planning Commission may be appealed to the City Council. Appeals must be submitted to the City Clerk in writing within 10 calendar days of an action by the Commission.







West Campbell Ave.





FOOTING DETAIL NORMAL LEG HEIGHT & 110 MPH WIND GUSTS



1. SIGN LEG
2. BASE PLATE (WELDED TO LEG AT FACTORY)
3. 1" X 30" ANCHOR BOLTS (QTY 4 REQUIRED)
 - GALVANIZED.
 - AS36 OR BETTER.
 - MAY BE PURCHASED WITH SIGN.
 - NOTE: TAPE THE THREADS OF THE ANCHOR BOLTS FOR PROTECTION AGAINST CONCRETE.
4. LEVELING NUT
5. SECUREMENT NUTS
6. WASHER
7. #4 REBAR (ASTM 615 GRADE 60 OR BETTER)
 - TIE EACH JOINT.
8. CONCRETE (3000 PSI MINIMUM)
9. HIGH STRENGTH NON-SHRINK GROUT
10. ELECTRICAL CONDUIT
 - ELECTRICAL CAN BE RUN UNDERGROUND IN CONDUIT BETWEEN ANCHOR BOLTS ON EITHER LEG (ON A SINGLE SIDED SIGN, ELECTRICAL IS IN THE RIGHT LEG).
11. REMOVABLE BLANK ELECTRICAL COVER
 - FOR CONNECTION OF POWER.


