Notice is hereby given that the Planning Commission of the City of Campbell has set the time of 7:30 p.m., or shortly thereafter, on Tuesday, **October 13, 2020**, for a STUDY SESSION to consider a Preliminary Application (PLN-2020-106) for an approximately 8,000 square-foot 2-story office building on property located at **1940 Hamilton Avenue**. This Planning Commission meeting will be conducted via telecommunication and is compliant with provisions of the Brown Act and Executive Order N-29-20 issued by the Governor.

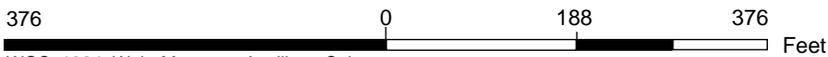
