
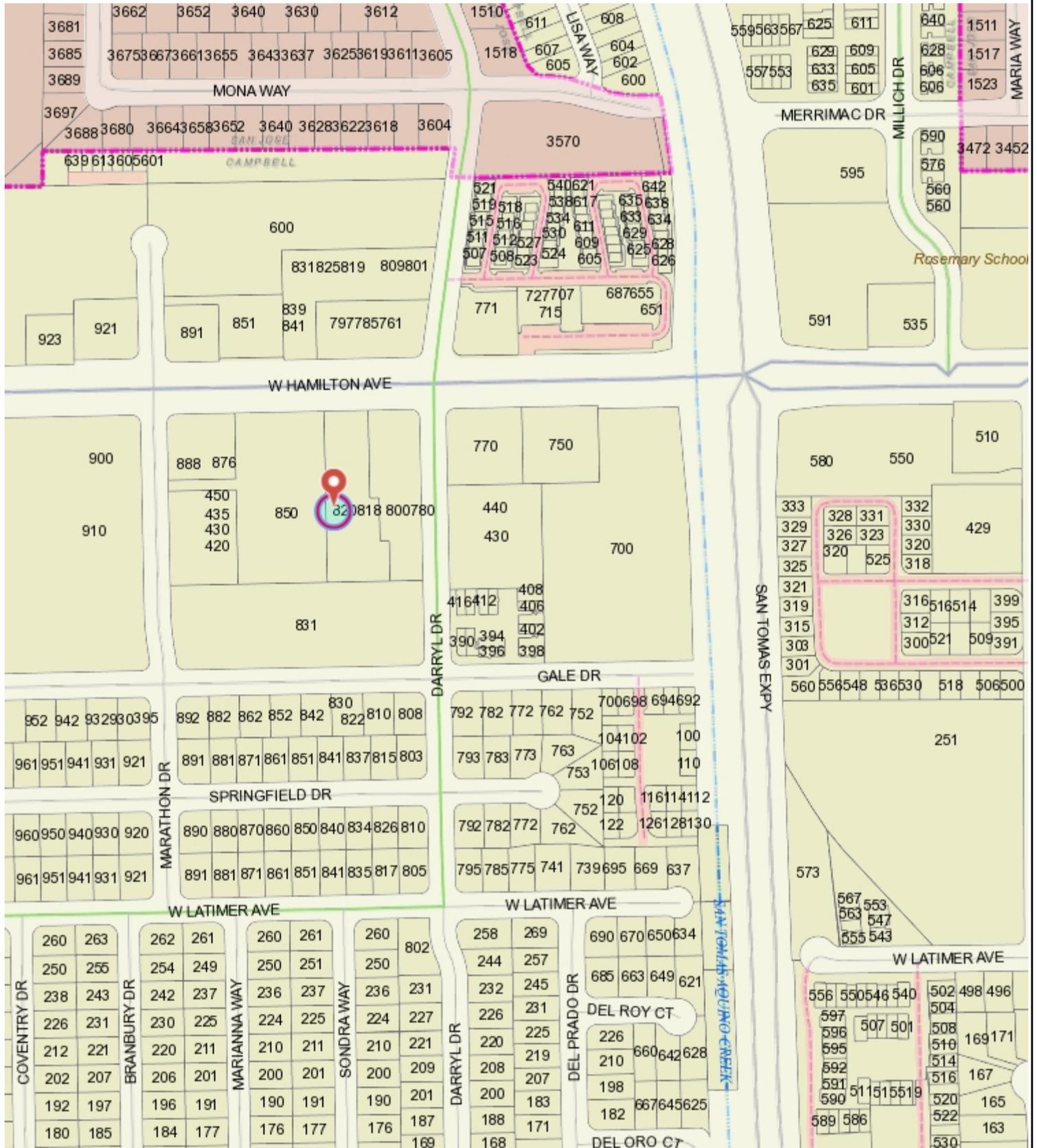

This project will be decided by the Community Development Director and you have the opportunity to provide comment prior to the Director's decision. The 10-day comment period for this application begins on July 23, 2021 and ends on August 2, 2021. Any comments regarding this application must be submitted in writing (including email) to the Planning Division before 5:00 p.m. on **August 2, 2021**. The Director will then consider all comments submitted within this time period prior to a decision. No additional notice will be provided. Please contact the project planner in a timely manner to determine what decision was reached.

Decisions by the Community Development Director are final in 10 calendar days following the date of approval, unless an appeal is received in writing at the City of Campbell Community Development Department, 70 N. First Street, Campbell, prior to the end of the appeal period. A written appeal must be accompanied with the required \$200 appeal filing fee. City Hall is currently closed to the public however plans and documents may be viewed on the City's 'Public Notices' web page (<http://www.cityofcampbell.com/501/Public-Notices>) under 'Administrative Decisions' or by contacting the project planner. To Whom it May Concern,

This project is a tenant improvement for a children's dance studio that is proposed to be located at a 5,436 unit in the shopping center at 842 W Hamilton Ave. in Campbell. This improvement will include a demolition of interior non bearing walls, lighting upgrade, installation of a 4 inch thick flooring system installed on top of the existing slab, and installation of new interior walls. Bathrooms will be updated for new plumbing count requirements and ada upgrades have been applied as necessary. If this project gets approval, fire sprinklers will be designed and relocated to accommodate the newly located interior walls.

The hours of operations for this facility will be from 7am-9pm Monday through Saturday with a maximum of 6 employees and 50 participants for a total of 56 occupants. Scheduling for the classes has not yet been established but the owner knows there should be 15 minute breaks in between classes to allow a buffer time to reduce traffic and congestion. Participants are of the pick up and drop off category as most of the participants will be children.

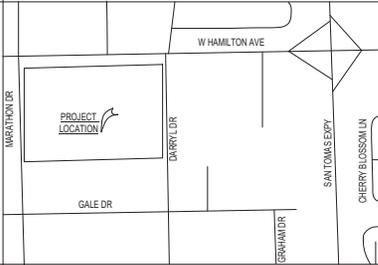

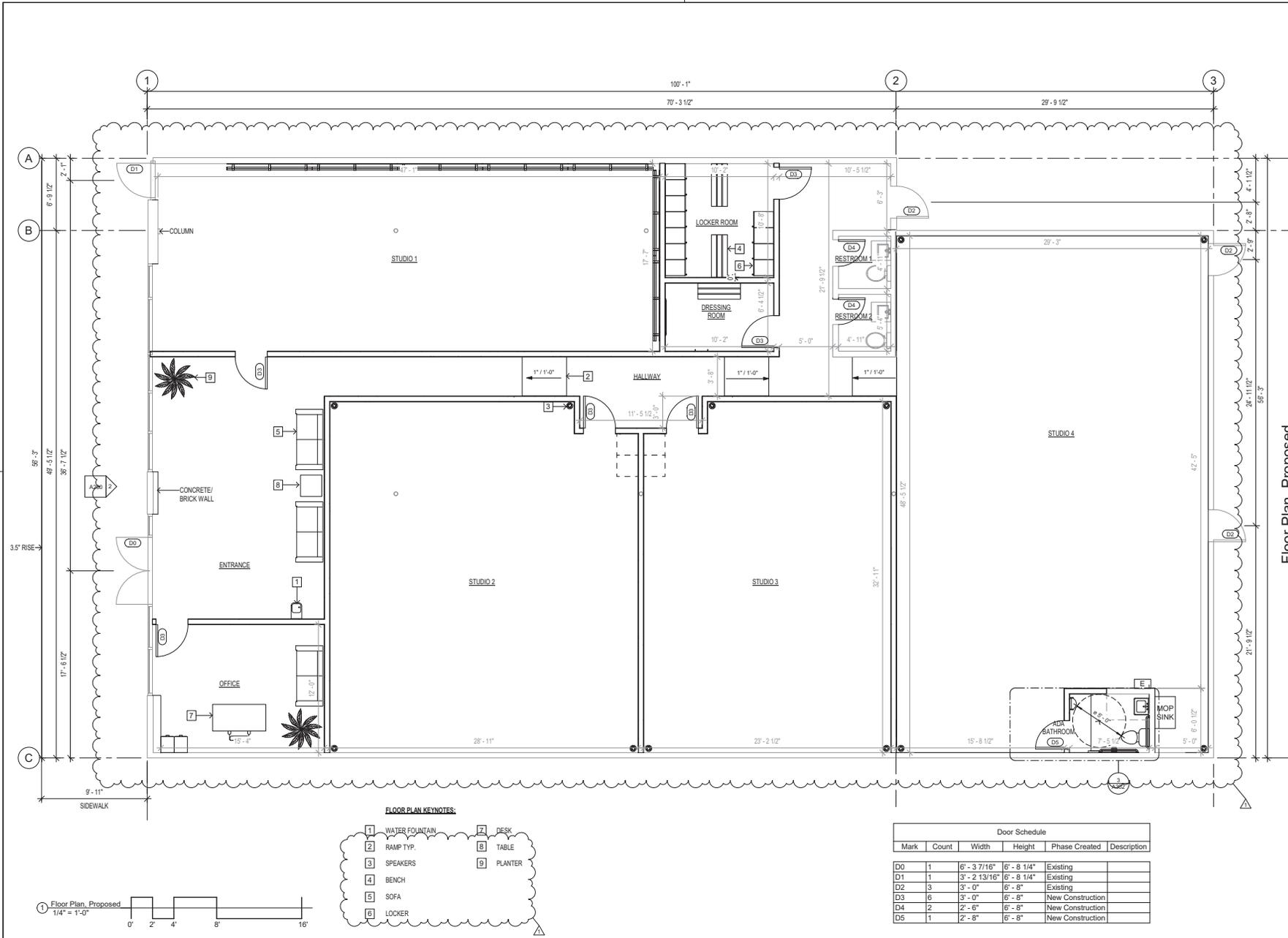
